AUTHORIZATION AND CONSENT FORM

Consent to Photograph and Video Record

Authorization for Digital Communication

Woodside School uses secure digital applications for daily communication. Each parent or guardian will be given an individual link to access their account for the application used by the classroom. The teaching staff document activities, meals, naps, and share photos on the app. The app enables parents/guardians to message the classroom directly throughout the day if necessary.

Please indicate your authorization to share your child's information with you on the digital app utilized by your child's classroom. Each child and families' information can only be seen by the authorized parent/guardian on the account and will not be viewed by other families.
